PUBLIC NOTICE

To sole owners of an immovable, sole occupants of a business establishment,
undivided co-owners of an immovable and co-occupants of a business establishment,
concerning the by-election of November 15, 2015

NOTICE is given to **sole owners of an immovable and sole occupants of a business establishment** who are not already entitled to be entered on the list of electors as domiciled persons, that they must meet the following conditions to be entered on the list of electors of the district:

1. be 18 or over on **November 15, 2015**;
2. on **September 29, 2015**, be a natural person, a Canadian citizen, and neither be under curatorship nor under any conviction for an offence constituting a corrupt electoral practice;
3. on **September 29, 2014**, have been the sole owner of an immovable or the sole occupant of a business establishment on the territory of the district;
4. have filed with the returning officer, at the address shown below, an application for entry on the list of electors, **by October 11, at 4:30 p.m.**

NOTICE is also given to **undivided co-owners of an immovable and co-occupants of a business establishment** who are not already entitled to be entered on the list of electors as domiciled persons, as sole owners of an immovable, or as sole occupants of a business establishment, that they must meet the following conditions to be entered on the list of electors of the district:

1. be 18 or over on **November 15, 2015**;
2. on **September 29, 2015**, be a natural person, a Canadian citizen, and neither be under curatorship nor under any conviction for an offence constituting a corrupt electoral practice;

3. on **September 29, 2014**, have been the undivided co-owner of an immovable or the co-occupant of a business establishment on the territory of the district;
4. have been designated under a power of attorney signed by the majority of co-owners or co-occupants who are qualified to vote on **September 29, 2015**;
5. have filed a power of attorney with the returning officer, at the address shown below, **by October 11, 2015, at 4:30 p.m.**

An application for entry or a power of attorney filed **after October 11, 2015, at 4:30 p.m., but no later than October 26, 2015, at 10 p.m.**, last day to file an application with the board of revisors, will be considered as an application for correction to the list of electors, and consequently, will be submitted to the board of revisors.

Applications for entry and power of attorney forms are available from the returning officer or on the Internet site. Applications for entry and powers of attorney take effect on receipt and remain valid as long as they are not withdrawn or replaced.
