It's my city, it's up to me !

PUBLIC NOTICE OF REVISION OF THE LIST OF ELECTORS

Notice is given to electors of Montréal that:

1. The list of electors was filed with the city archives on **September 14, 2009**. It is subject to revision before being used for the general election.
2. To be an elector and qualify for entry on the list of electors, every person must:
 - be an individual
 - be 18 or over on **November 1, 2009**

and, on **September 1, 2009**,

- be a Canadian citizen
- not be under curatorship
- not be disqualified under the law

Every person must also meet one of the following conditions:

- have been domiciled on the territory of Montréal on **September 1, 2009**, and in Québec since **at least March 1, 2009**;
or
- have been the sole owner of an immovable on the territory of Montréal since **at least September 1, 2008**, and have filed a written application for entry with the returning officer, **or**
- have been the sole occupant of a business establishment on the territory of Montréal since **at least September 1, 2008**, and have filed a written application for entry with the returning officer.

Where an immovable belongs to undivided co-owners or where a business establishment is occupied by co-occupants, no person other than the undivided co-owner or the co-occupant designated under a power of attorney signed by the majority of co-owners or co-occupants who are electors, may be entered on the list of electors as owner of the immovable or co-occupant of the business establishment. The power of attorney must be filed with the returning officer.

A person who is an elector in more than one capacity may be entered on the list of electors in only one capacity, in the following order of precedence:

- as a domiciled person
- as the sole owner of an immovable
- as the sole occupant of a business establishment
- as the undivided co-owner of an immovable
- as the co-occupant of a business establishment

No person may be entered at more than one place on the list of electors of Montréal.

• IMPORTANT •

Where an application for entry of a person domiciled on the territory of Montréal is filed, the person who files the application with a board of revisors must specify the previous address of the person concerned, and produce 2 documents: one confirming his name and date of birth, and the other, his name and present home address.

You may consult the list of electors and file applications for entry, correction or striking off with the board of revisors of **your choice**, on the following dates and times:

Sunday, September 27 – 10 a.m. to 6 p.m.

Monday, September 28 – Noon to 10 p.m.

Tuesday, September 29 – 10 a.m. to 8 p.m.

Wednesday, September 30 – 10 a.m. to 8 p.m.
